Thank you for choosing Rideshare Depot for your rideshare vehicle rental in Greenville, South Carolina! This summary outlines key terms from our Rental Agreement, which governs your rental. Review the full Rental Agreement at ridesharedepot.com/rental-terms or at pickup.

Rental Fees

- Base Weekly Fee: Varies by vehicle (e.g., Tesla Model 3, Hyundai Elantra), specified at booking, plus 6% South Carolina sales tax. Paid weekly via Uber earnings deduction or alternative payment.
- Deposit: Refundable, equal to one day's rental (weekly fee divided by 7, plus 6% sales tax), due at booking. Refunded within 7 days of vehicle return, minus any fees/damages.
- Add-Ons: Additional add-ons (if selected) incur extra fees, plus 6% sales tax, specified at booking.
- All fees are transparent per SC Code § 56-31-50.

Mileage

- Included: 2,100 miles/week (300 miles/day).
- Overages: \$0.35/mile for additional miles, itemized weekly.

Charging/Fueling

- Electric Vehicles (EVs): Use Tesla Superchargers or approved chargers (see Vehicle Guide). Return with 80–100% battery capacity, or a \$1/kWh re-charging fee applies. Supercharger costs are itemized weekly with 6% sales tax.
- Gasoline Vehicles: Use 87 octane unleaded fuel. Return with a full tank, or a \$6/gallon re-fueling fee applies.

- Follow the Vehicle Guide (provided at pickup) to avoid damage or fees.

Insurance

- Rideshare Depot Provides: Liability (\$100,000/\$300,000) and collision coverage (\$500 deductible), excluding intentional damage or non-approved drivers.
- Renter Responsibility: Maintain rideshare-compliant insurance per South Carolina law (SC Code § 58-23-1690) and platform requirements (e.g., Uber, Lyft).

Vehicle Care

- Use the vehicle only for approved rideshare activities.
- Report accidents or issues immediately to support@ridesharedepot.com or (864) 982-8565.
- Return the vehicle clean to avoid a \$150 cleaning fee.

Termination

- Early termination requires 24-hour notice, with prorated fees based on the daily rate (weekly fee divided by 7, plus 6% sales tax). Deposit refunded within 7 days, minus fees/damages.
